Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to tCO₂e, a 40%ge reduction against the 2021 baseline and the measures will be in effect when performing the contract

In the future we hope to implement further measures such as:

- Increase the number of electric vehicles in the fleet
- Online Meetings both internal and external
- Encourage staff sharing car and using public transport
- Remote work scheme
